**MINUTES OF TELECONFERENCE MEETING  
March 28, 2006**

By authority of AS 08.01.070(2) and in compliance with the provision of AS 44.62, Article 6, a scheduled teleconference meeting of the Board of Pharmacy was held on March 28, 2006 at the State Office Building, 9<sup>th</sup> Floor, Room C, in Juneau, AK.

Ms. Bueler read the proposed regulations for 12 AAC 52.300 and 12 AAC 52.310. The proposed regulations would allow the board to include a jurisprudence questionnaire to the license renewal requirements for pharmacists and technicians.

Mr. Maiquis informed the board that no public comment was received regarding the proposed regulations. It was noted that all pharmacists and technician licensees were mailed a copy of the proposed regulations.

**On a motion duly made by Ms. Mundell, seconded by Ms. Soden, and approved unanimously by voice vote, having considered public comment and cost to private persons, it was**

**RESOLVED to adopt the proposed regulation changes to 12 AAC 52.300  
and 12 AAC 52.310.**

Ms. Soden asked if the proposed regulations regarding increase of licensing fees was moving forward. Mr. Maiquis confirmed that the public comment period was over March 20<sup>th</sup> and the regulation was moving forward.
