### **Class-A Assistant Guide License Application Instructions**

Qualifications for a Class-A Assistant Guide License. A natural person is entitled to a Class-A Assistant Guide license if the person

- (1) is 21 years of age or older.
- (2) possesses a valid first aid card (basic first aid) issued by the American Red Cross or similar organization
- (3) meets the eligibility requirements set out in AS 08.54.605 (page 2); and either
  - (A) has been employed during at least three calendar years as any class of licensed guide in the game management unit for which the license is sought, can provide documentation of at least 60 days of big game guiding activity in three or more calendar years and has at least 10 years' hunting experience in the state; military service outside of the state for not more than 3 years shall be accepted as part of the required 10 years' hunting experience.

#### OR

(B) provide evidence that you physically reside in the game management unit in, which you are to be employed, evidence that you have had at least 15 years' hunting experience in the game management unit in which you are to be employed; military service outside of the state for not more than 3 years shall be accepted as part of the required 10 years' hunting experience, and a written recommendation from a registered guide- outfitter, who intends to employ you as a class-A assistant guide.

**Note:** For the purposes of satisfying the hunting experience requirements, you must have at least 20 days of big game hunting activity in a calendar year in order to receive credit for that year.

The following must be received by the division before your application for Class-A Assistant Guide License can be reviewed:

### 1. APPLICATION

A signed, completed application (#08-4008, pages 1-5).

### 2. FEES

Fees made payable to "State of Alaska."

Nonrefundable Application Fee: \$200.00 Resident License Fee: \$310.00 Nonresident License Fee: \$620.00

### 3. CRIMINAL JUSTICE REPORT

A complete report of criminal justice information and fish and wildlife violations under AS 12.62. The Alaska report can be obtained by contacting the Department of Public Safety, Alaska Wildlife Troopers. You will need to purchase a criminal history report and make a point of asking for the fish & wildlife violations report.

In addition to the Alaska report, if a state other than Alaska is your primary state of residence, you must submit an equivalent report from your state of residency. Nonresident applicants will need to contact their state troopers office to obtain the report of criminal justice information and fish and wildlife violations report.

### 4. VERIFICATION OF LICENSURE

Verification of licensure status from each state, or Canadian jurisdiction, where you hold or have held a license to provide guiding, outfitting, transportation, or other hunting services license, if any, which is to be submitted directly to the Division of Corporations, Business and Professional Licensing from the issuing government body.

### 5. VALID FIRST AID CARD

A copy of your valid first aid (basic first aid) card issued by the Red Cross or similar organization.

### 6. JURISPRUDENCE QUESTIONNAIRE

A completed Jurisprudence Questionnaire (#08-4006) found on the board's Applications & Forms webpage.

### 7. SUPPORTING DOCUMENTATION

Supporting documentation that is required for option A or B, whichever applies.

### **ELIGIBILITY FOR LICENSURE** – AS 08.54.605

- (a) A person may not receive a license if
  - (1) the person has been convicted of
    - (A) a violation of a state of federal hunting, guiding, or transportation services statute or regulation for which
      - (i) the person was imprisoned for more than five days within the previous five years;
      - (ii) an unsuspended fine of more than \$2,000 was imposed in the previous 12 months;
      - (iii) an unsuspended fine of more than \$3,000 was imposed in the previous 36 months; or
      - (iv) an unsuspended fine of more than \$5,000 was imposed in the previous 60 months;
    - (B) a felony within the last five years;
    - (C) a felony offense against the person under AS 11.41 within the last 10 years; or
  - (2) the person's right to obtain, or exercise the privileges granted by a hunting, guiding, or outfitting, or transportation services license is suspended or revoked in this state or another state or in Canada.

**Note:** It is unlawful for a person to guide without having a current, valid guide license and hunting license in actual possession.

#### **Class-A Assistant Guides:**

- 1. may not contract to guide or outfit a big game hunt;
- 2. shall be employed by and under the supervision of a registered guide-outfitter who has contracted with the client for whom the class-A assistant guide is conducting the hunt;
- 3. may take charge of a camp and conduct guide activities from the camp without the contracting registered guide-outfitter being in the field and participating in the contracted hunt if the contracting registered guide-outfitter is supervising the guiding activities;
- 4. may not perform functions of a class-A assistant guide outside of the GMU for which the license is issued; and
- 5. may be employed by a registered guide-outfitter to perform the functions of an assistant guide in any GMU.

**Be advised:** The Big Game Commercial Services Board will seek maximum penalties for big game commercial services license holders who are found to have violated a hunting, guiding and/or transportation services statute or regulation.

### **Definitions**

**Person,** according to AS 01.10.060(a)(8), a "person' includes a corporation, company, partnership, association, organization, business trust, or society as well as a natural person.

Natural person means a living, breathing human being, as opposed to a legal entity such as a corporation.

Resident AS 16.05.940(27), "resident" means a person who for the 12 consecutive months immediately preceding the time when the assertion of residence is made has maintained the person's domicile in the state and who is neither claiming residency in another state, territory, or country nor obtaining benefits under a claim of residency in another state, territory, or country; a partnership, association, joint stock company, trust, or corporation that has its main office or headquarters in the state; a natural person who does not otherwise qualify as a resident under this paragraph may not qualify as a resident by virtue of an interest in a partnership, association, joint stock company, trust, or corporation; a member of the military service, or United States Coast Guard, who has been stationed in the state for the 12 consecutive months immediately preceding the time when the assertion of residence is made; a person who is the dependent of a resident member of the military service, or the United States Coast Guard, and who has lived in the state for the 12 consecutive months immediately preceding the time when the assertion of residence is made; or an alien who for the 12 consecutive months immediately preceding the time when the assertion of residence is made has maintained the person's domicile in the state and who is neither claiming residency in another state, territory, or country nor obtaining benefits under a claim of residency in another state, territory, or country.

**Pilot Experience Requirements.** If you personally pilot an aircraft to transport clients during the provisions of big game commercial hunting services, you must show proof of a current commercial pilot's license or 500 hours of flying time in the state (AS 08.54.680(b)).

Law Enforcement Officers. If you are a fish and game law enforcement officer for the State of Alaska, United States Department of the Interior or the United States Department of Agriculture, you may not hold or earn experience credits to apply for a Registered Guide-Outfitter license while you are a law enforcement officer and for three months after termination status as a law enforcement officer (AS 08.54.640(a)).

**Game Biologists.** A person who holds any class of guide license and who is employed by the Department of Fish and Game or a federal wildlife management agency may not, while employed by the department or agency as a game or wildlife biologist and for 12 months after leaving employment with the department or agency as a game management or wildlife biologist, engage in providing big game hunting services in a game management unit in which the person conducted game or wildlife management or research activities for the department or agency at any time during the preceding 12 months (AS 08.54.640(c)).

### **General Information**

#### APPLICATION PROCESSING:

The average time to process a paper application varies by program but can take several weeks from the date it is received in this office complete with all correct forms, supporting documents and appropriate fees paid. When the application is complete and correct, and all supporting documents have been received and all fees have been paid, the license will be issued. Start the process far enough in advance to allow for processing time. Applications are reviewed in order of receipt in our office, and walk-in customers should not expect immediate review.

#### LICENSE TERM:

There is no "inactive" status. If you choose not to renew your license, it will lapse. Licenses are issued for a two-year period and expire on December 31 of odd-numbered years, regardless of the date of issuance, except licenses issued within 90 days of the expiration date are issued to the next biennial expiration date. Renewal applications become available 30-90 days prior to the expiration date. One renewal notice will be sent via email or mail at least 30 days before license expiration to the last known email or mailing address of record. Failure to receive a renewal notice does not alleviate the requirement to renew the license if you wish to continue providing services in Alaska.

### **PROFESSIONAL FITNESS QUESTIONS:**

A "yes" response in the application does not mean your application will be denied. If you have responded "yes" to any professional fitness questions in the application, be sure to submit a signed and dated explanation, and the charging document and judgement.

#### **DENIAL OF APPLICATION:**

Please be aware that the denial of an application for licensure may be reported to any person, professional licensing board, federal, state, or local governmental agency, or other entity making a relevant inquiry or as may be required by law.

### **RANDOM AUDIT:**

If your program requires continuing education, the Division will audit a percentage of the license renewals. If your license is randomly selected for audit, a letter will be sent with instructions to submit documentation as proof you satisfied the continuing competency requirements as stated on this renewal form. Licensees are randomly selected by computer and may be randomly selected as often as the computer program chooses. You must save your documents for at least four years so you can respond to audits.

#### **ADDRESS OR NAME CHANGE:**

In accordance with 12 AAC 02.900, it is the applicant's/licensee's responsibility to notify the Division, in writing, of changes of address or name. Name and address change notification forms are available on the Division's website. The address of record with the division will be used to send renewals and all other official notifications and correspondence. The name appearing on the license must be your current legal name.

### **CERTIFIED TRUE COPIES:**

If any of the required documents will be issued under a former name, indicate on the application and submit marriage license and/or court documents that are notarized as a "certified true copy of the original document". To obtain a certified true copy, you must present the notary with the original document along with the photocopy. You must write, "I certify this is a true copy of the original document" and sign your name. The notary will compare the original document with the copy and then notarize your signature.

### **SOCIAL SECURITY NUMBERS:**

AS 08.01.060 and 08.01.100 require that a U.S. Social Security Number be on file with the division before a professional license is issued or renewed for an individual. If you do not have a U.S. Social Security Number, please complete the Request for Exemption from Social Security Number Requirement form (#08-4372) located at *ProfessionalLicense.Alaska.Gov* or contact the division for a copy of the form. This form is required with every application if you do not have a U.S. Social Security Number.

### **PUBLIC INFORMATION:**

Please be aware that all information on the application form will be available as a public record, unless required to be kept confidential by state or federal law.

### **ABANDONED APPLICATIONS:**

Under 12 AAC 02.910, an application is considered abandoned when 12 months have elapsed since correspondence was last received from or on behalf of the applicant. An abandoned application is denied without prejudice. At the time of abandonment, the division will send notification to the last known address of the applicant, who has 30 days to submit a written request for a refund of biennial license and other fees paid. The application fee will not be refunded. If no request for refund is received within that timeframe, no refund will be issued, and all fees will be forfeited.

### **BUSINESS LICENSES:**

The status of a professional license will directly impact the status of an associated business license. Renewal applications for business licenses are mailed separately. For more information about business licenses, (907) 465-2550 or *BusinessLicense.Alaska.Gov* 

#### **STALE DOCUMENTS:**

Application forms, authorizations and verifications older than 12 months from the date the document was received by the division will be considered stale; the document must be resubmitted as appropriate before the application will be considered by the division or a licensing board. Application documents include the application documents and verifications of licensure from other licensing jurisdictions. (12 AAC 02.915)

### **PAYMENT OF CHILD SUPPORT:**

If the Alaska Child Support Enforcement Division has determined that you are in arrears on child support, you may be issued a nonrenewable temporary license valid for 150 days. Contact Child Support Services at (907) 269-6900 to resolve payment issues.
